**About South Central Industries and Benefits:**

South Central Industries, Inc. provides vocational training, employment opportunities, residential services and social outlets that will help individuals with developmental disabilities achieve their maximum potentials by integrating independence, self-sustainability and productivity into all facets of their lives. South Central provides a full benefit package to all full-time employees, including health insurance, vision insurance, life insurance, \$50,000 short-term disability, and a supplemental cancer, stroke, and heart attack insurance policy. Additionally, South Central contributes 2% of an employee’s salary to our employer-sponsored retirement plan. Staff enjoy eleven paid holidays throughout the year and receive 13 days of paid time off in their first year of employment, increasing by one day per year with each additional year of employment.

**Duties and Responsibilities:**

1. Supervises and coordinates activities of drivers.
2. Plans routes and schedules drivers, vehicles, and deliveries based on driver, company, and customer information.
3. Oversees loading and dispatching of trucks.
4. May investigate customer complaints and pay claims for damaged articles.
5. May load and drive vehicle to designated areas.
6. Oversee time logs of drivers.
7. Follow all safety guidelines, including securing vehicles.
8. Follow traffic laws at all times.
9. Keep trucks cleaned and maintained.
10. Obtain appropriate paperwork for deliveries from Warehouse Supervisor.
11. Make deliveries of items to designated destination.
12. Quality Assurance: Ensure order accuracy prior to delivery. Count product before loading.
13. Every morning, turn in all paperwork from the previous day’s route to the front office.
14. Track objectives and action steps daily for clients under your daily supervision.
15. Assist clients with all needs including safety, hygiene and mealtimes.
16. Coordinate with client’s home contact for daily arrival and pick up times.
17. Notify Program Manager of any issues concerning vehicle safety and performance.
18. Fuel vehicle as needed.

19. Notify Program Manager immediately of any concerns about clients under your daily supervision.
20. Other duties as assigned.

**Advancement Opportunities:**

This position qualifies for advancement opportunities, depending upon availability and job performance. Opportunities include promotion to Program Manager or Warehouse Supervisor.

**Supervisory Responsibilities:**

This position supervises all drivers and any clients they are assigned on a daily basis.

**Qualifications:**

Candidates for this position must be at least 18 years of age and have a combination of education and experience necessary to meet the expectation required and the responsibilities as outlined.

(South Central will send you to training. Training is mandatory to keep position).

**Environmental Conditions:**

Moderate exposure to hazardous risks, including potential for exposure to infections and communicable diseases, blood and body fluids, electrical equipment, chemicals, such as alcohol and Clorox. Must follow universal safety precautions. Contact with adults who may exhibit physical, behavioral outbursts related to a mental health condition.

**Security:**

**Physical Demands:**

- Standing and walking: Must be able to walk/stand up to 90% of the time.
- Bending: May bend several times in order to meet the needs of the service recipient
- Carrying: May carry up to 50 pounds. May move equipment (average push force 20 pounds.)
- Lifting: May lift several times to meet the needs of the service recipient.
- Pushing: Minimal.
- Reaching: Several times in order to meet the needs of the service recipient
- Hand/Finger Dexterity: Minimal. May apply pressure with hands.
- Kneeling: may kneel in order to meet the needs of the service recipient.
- Vision: Must be able to see in order to read and write
- Hearing: Must have hearing sensitivity aided or unaided

Driver Supervisor is hired by the Program Manager and HR and is supervised by the Program Manager, Logistics Manager, and/or Executive Director.
